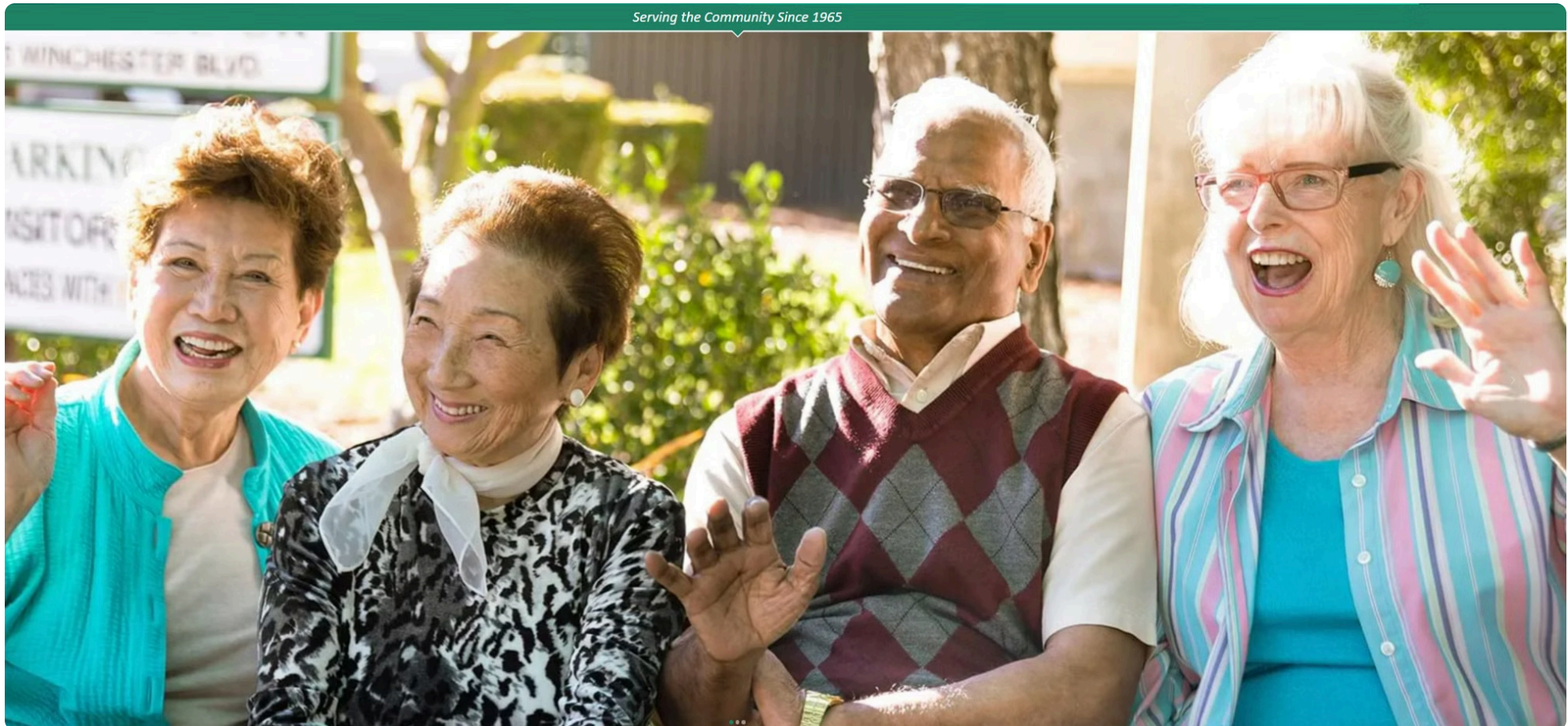


Background

- Organization: Santa Clara Methodist Retirement Foundation (SCMRF)
- Location: Northern California, Multiple locations, over 400 residents
- Established: 1965
- Mission: To provide affordable housing and services for low-income seniors.

Mission Statement

SCMRF has been dedicated to supporting the elderly community in Northern California by offering affordable housing options and essential services. With an increasing need to modernize its operations and improve service delivery, SCMRF decided to migrate its IT infrastructure to Microsoft Azure and adopt Office 365 for enhanced productivity and collaboration.



Challenges

1 Aging IT Infrastructure

SCMRF's on-premises servers and software were becoming obsolete, leading to increased maintenance costs and potential security vulnerabilities.

3 Remote Work

The need for better support for remote work and collaboration tools became evident, especially post-pandemic.

2 Scalability

The existing infrastructure lacked the flexibility to scale operations efficiently as the organization grew.

4 Data Security and Compliance

Ensuring data security and compliance with regulations was a growing concern.

Solution: Migration to Microsoft Azure and Office 365

1

Assessment and Planning

Conducted a thorough assessment of current IT infrastructure. Identified critical applications and data to be migrated. Developed a detailed migration plan with minimal disruption to ongoing operations.

2

Azure Migration

Migrated on-premises servers and applications to Azure Virtual Machines. Utilized Azure Storage for scalable and secure data storage. Implemented Azure Active Directory for centralized identity and access management.

3

Adoption of Office 365

Transitioned to Office 365 for enhanced productivity and collaboration tools, including Exchange Online, SharePoint, Teams, and OneDrive. Provided training sessions for staff to ensure smooth adoption of new tools.

4

Data Security and Compliance

Leveraged Azure Security Center and Office 365 Security & Compliance Center to monitor and manage security. Implemented data encryption, multi-factor authentication, and regular security audits.

5

Cost Management

Adopted Azure's pay-as-you-go pricing model to optimize costs. Utilized Azure Cost Management and Billing tools to monitor and control spending.
